

Freedom of Information Act

Under the freedom of information act 2000 all public authorities are required to have and operate a publication scheme approved by the Information Commissioner.

It is the intention of the Information Commissioner that all public authorities should adopt and operate the model scheme that has been approved. The approved model is very general and is based on the principle that all public authorities should recognise the public interest in the transparency of the services provided for and paid for by the general public. It is a commitment to make information easily available to the public.

The scheme applies only to the information held as public authority, it does not include information that is not held, is held for other purposes or would be exempt from release.
